TTA JUDGING LIST CRITERIA

Experience Expected for the A1 List.

Persons who have previously been approved by the Kennel Club to award CCs in the Breed and have completed their first appointment. To have the support of the Tibetan Terrier Association to award CCs in the Breed.

Experience Expected for the A2 List.

Persons who fulfil the requirements for the A3 List and who have been assessed in accordance with Kennel Club requirements and accepted by the Kennel Club for inclusion on an A2 List and have the support of the Tibetan Terrier Association.

Experience Expected for the A3 List (Breed Specialists)

- 1) Owned a Tibetan Terrier for at least 10 years.
- 2) Judged Tibetan Terriers for a minimum of 7 years and have the support of the Tibetan Terrier Association.
- 3) Judged Tibetan Terriers at at least 8 shows with at least 32 classes and at least 125 dogs present, preferably to have included at least one sex at a Tibetan Terrier Breed Club show.
- 4) Attended at least 2 additional Tibetan Terrier seminars whilst on the "B" List.
- 5) Achieved a pass in the Higher Judging Certificate Examination of the TTA or TTBOC Judging Examination.
- 6) To have attended a seminar given by a Kennel Club Accredited Trainer, and passed the relevant examination on Kennel Club Regulations and Judging Procedures.
- 7) To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement.
 - (a) To have attended a Conformation & Movement 'Hands On' Assessment conducted by a Kennel Club Accredited Trainer and passed the assessment.
- 8) To have attended at least one breed specific seminar run in accordance with the relevant Kennel Club Code of Best Practice and passed an examination and/or assessment where applicable.
- 9) To have bred and/or owned a minimum of 3 dogs when they obtained their first entry in the Kennel Club Stud Book. (Save in exceptional circumstances)
- 10) To have stewarded at a minimum of 12 shows.

Experience Expected for the A3 List (Non Specialists)

- 1) Judged for a minimum of 7 years in any one breed (to include 5 years in this breed) and have the support of the Tibetan Terrier Association.
- 2) Judged Tibetan Terriers at at least 8 shows with at least 32 classes and at least 125 dogs present, preferably to have included at least one sex at a Tibetan Terrier Breed Club show.
- 3) To have awarded CCs in at least one other breed.
- 4) Attended at least 2 additional Tibetan Terrier seminars whilst on the "B" List.
- 5) Achieved a pass in the Higher Judging Certificate Examination of the TTA or TTBOC Judging Examination.
- 6) To have attended a seminar given by a Kennel Club Accredited Trainer, and passed the relevant examination on Kennel Club Regulations and Judging Procedures.
- 7) To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement.
- 8) To have attended at least one breed specific seminar run in accordance with the relevant Kennel Club Code of Best Practice and passed an examination and/or assessment where applicable.
- 9) To have bred and/or owned a minimum of 3 dogs when they obtained their first entry in the Kennel Club Stud Book. (Save in exceptional circumstances)

Experience expected for the B List (Breed Specialists)

- 1) Owned Tibetan Terriers for at least 5 years.
- 2) Attended at least 2 seminars for Tibetan Terriers.
- 3) Achieved a pass in the Basic Judging Certificate Examination of the TTA or TTBOC

Experience expected for the B List (Non Specialists)

- 1) Should have owned their own breed for at least 5 years and must be on a judging list for their own breed.
- 2) Attended at least 2 seminars for Tibetan Terriers.
- 3) Achieved a pass in the Basic Judging Certificate Examination of the TTA or TTBOC

C List (Breed Specialists)

For aspirant judges who have shown an interest in the breed and have the support of the Tibetan Terrier Association.

C List (Non Specialists)

For aspirant judges who have shown an interest in the breed and have the support of the Tibetan Terrier Association.

NB: The TTA Judging Certificate Exams were introduced for the 1996 lists. Judges who have passed the exams are shown on the lists with the grade obtained. Judges who were on the lists prior to the introduction of the exams remain on the list they were on in 1995 if they have not sat and passed the exam since then.

The exam guidelines follow the guidelines set out in the Kennel Club's Judges Working Party Report.

Excerpt from TTA Rules

13. a) Judging lists will be drawn up annually in compliance with Kennel Club Regulations and Directives.
- c) Applications for inclusion in the judging lists may be made at any time during the year. They must be in writing to the Honorary Secretary and include information supporting and justifying the application.
